## Directorate of Veterinary Services Sub-division: Traceability, Medicine Control and Advisory Services



### What is NamLITS?

NamLITS is a Namibian Livestock Identification and Traceability System used for the identification and traceability of livestock in Namibia. The system is under the administration of the Directorate of Veterinary Services and is accessible from anywhere in the country.

### Importance of NamLITS:

- Issue livestock movement permits for livestock moving from farm to farm, gathering events such as auctions as well as abattoirs for slaughter
- Provides reports such as herd statement which is a summary of all the livestock registered on a livestock keepers stockbrand and 90/40-day reports for animals moving to an export abattoir for slaughter such as MeatCo and Beefcor
- Termination of livestock that have slaughteredor died due to natural causes for an accurate herd count
- Transfer of livestock from one stockbrand to another when livestock are sold to another livestock keeper

### Requirements for a livestock keeper to be registered on NamLITS?

- Stockbrand certificate or stockbrand card both issued by the MeatBoard of Namibia-Stockbrand Office
- Certified copy of the ID document
- Title deed, lease agreement or a traditional authority letter as proof of ownership of the place where the livestock are kept
- Complete a notification of holding form available at any district veterinary office.


## STOCKBRANDS

### What is a stockbrand?

Is a unique number and letter combination used to identify animals issued by the MeatBoard of Namibia. All individuals keeping livestock are required by law to register for a stockbrand within 14 days of keeping livestock.



The stockbrand is applied on the livestock once the livestock keeper is issued a stockbrand as a means of identification.



There are three types of stockbrands which are issued as per stockbrand area

- 1.Commercial stockbrands
- 2.Communal stockbrands
- 3.STUD stockbrand

# Requirements for applying for a stockbrand:

- Commercial stockbrand: title deed or lease agreement
- Communal stockbrand: traditional authority letter
- STUD stockbrand: registered member with a Pedigree or breeders association
- Certified copy of ID documents
- Application fee(subjected to annual price increase)
- Takes a maximum of 2 weeks to process at the MeatBoard of Namibia Stockbrands Office

# LIVESTOCK MOVEMENT PERMITS

## What is a livestock movement permit?

It is legal document that allows for the movement of livestock from one place to another. It is valid for 14 days from the date of issue and must be returned to the nearest state veterinary office after use for a single movement.

# Requirements for applying for a livestock movement permit:

- Stockbrand card/certificate
- Official, valid ID card
- Name of establishment(farm) where applicant (livestock keeper) registered on NamLITS
- Complete the application form for a livestock movement permit on NamLITS Online or at your local state veterinary office

## EAR TAGS

**Before a livestock keeper can purchase ear tags, a manual ear tag quota is required and** A manual ear tag quota is the number of ear tags that a farmer qualifies to buy based on number of eartags registrations and replacements done in the past 2 years. The quota is issued by the district state veterinarian of the area where the livestock keeper is farming.


## What are ear tags?

Official, approved devices used to identify prescribed animals. They are made up of a twopiece RFID and plastic conventional ear tag approved for identification in Namibia. **NB: Once the ear tag is placed on the ear of the animal, it remains on the animal for life. It is against the law to temper or remove ear tags.** 

## Important features of an official ear tags:

1. Ear tag identification number

### Which animal types should be tagged by law?

All livestock (cattle, sheep and goats) are required by law to be identified by means of official ear tags whether they are residing North or South of the Veterinary Cordon Fence (Red line)

Cattle at 6 months of age or upon first movement

Small stock (Sheep and Goats) at 3 months or upon first movement




# Importance of tagging livestock

· Certified id copy of stock brand owner.

· Certified copy of Stock brand certificate.





## NAMLITS ONLINE

### What is NamLITS Online?

NamLITS Online is a web-based extension of the NamLITS live system that allows farmers to perform functions related to herd such as registration of new ear tags, apply for movement permits and manage their herd related information.



### What do you need to register for a NamLITS Online account?

- Registered stockbrand
- Livestock keeper key (unique ID number on the NamLITS assigned to each registered stockbrand)
- An e-mail address
- Stable, reliable internet connection
