# IMPLEMENTATION GUIDELINES FOR THE COMPREHENSIVE CONSERVATION AGRICULTURE PROGRAMMES 2024/25

### 1. Background

The Ministry of Agriculture, Water and Land Reform (MAWLR) is implementing the Comprehensive Conservation Agriculture Programme (CCAP) in the 14 Regions of Namibia targeting small and medium scale cereal and horticulture farmers. The overall objective of the programme is to reduce and reverse land degradation and to mitigate the impact of climate change through the adoption of Conservation Agriculture (CA) as a basis for sustainable crop production and improved food security at national and farm level. Through this programme the Ministry is promoting three CA principles:

- Continuous minimum mechanical soil disturbance,
- · Permanent organic soil cover,
- Diversification of crop species

### The Programme specifically aims to:

- Increase awareness and knowledge of CA among stakeholders, including farmers, extension workers, researchers and policy and decision-makers.
- Increase farmers and extension workers skills of practicing CA.
- Conduct farmer-focused research to develop appropriate CA technologies and packages for the farming systems.
- Establish institutional arrangements for harmonised and coordinated implementation of the CA programme.
- Ensure farmers have access to CA equipment, inputs, services and markets.
- Develop standards, monitor and evaluate adoption and impact of CA.

### 2. Programme implementation

## 2.1 Provision of advisory services on Conservation Agriculture

The planned activities for the 2024/25 CCAP is presented in table 1 below.

### 2 Institutional Implementation framework

The government recognizes that it cannot implement the programmes alone and therefore, considers the involvement of stakeholders as key success to the programme.

- The Directorate of Agricultural Production, Extension and Engineering Services (DAPEES)
  will oversee the implementation of the programme in the regions including awareness
  creation, monitoring, and facilitate training including demonstrations, exposure visits, farmer
  information and field days.
- The Directorate of Research and Development (DARD) will take a lead in all research related aspects of the programme including soil analysis and fertility management options, provide foundation seeds for multiplication, development and adaption of farm implements, machineries, and evidence based practices and technologies to improve yields.

Furthermore, DARD to coordinate research activities with academic and other research institutions.

- The implementing Regional Councils shall be responsible for the payments related to the programme. Furthermore, the Regional councils together with the DAPEES Regional Heads shall provide financial reports and bank statements for the programme.
- Traditional Authorities and Regional Councilors shall support in creating awareness on the programme.

### 3 CCAP Budget 2024/25

• The CCAP received an allocation of Three Million Namibian Dollars (N\$3,000,000.00), for the 2024/25 financial year. Budget breakdown is presented in table 2 below.
